Appointment of Chartered Accountant

Competitive rates are invited from the Chartered Accountants empanelled with CAG, HP to conduct the audit of HP Rural Development Employment Guarantee Fund Account (MGNREGA) for the FY 2016-17. (The balance sheet of the State Employment Guarantee Fund Account is to be prepared and to conduct the audit of State Debit Account and consolidation of District Accounts of 12 districts (Balance sheets, income & expenditure statement, receipt and payment account and bank reconciliation) at State level). In addition to this, the audit of MGNREGA administrative expenditure account at State level is also to be conducted.

The minimum fee for conducting the audit of the above mentioned accounts for the financial year 2016-17 is Rs. 31500/ + service tax. The fee can be quoted less than the minimum fee. The CA appointed by the HPRDEGS has to complete the audit within a weeks time from the receipt of balance sheet of all the district. The CA who has conducted the audit of HP Rural Development Employment Guarantee Society Account (MGNREGA) for the year 2014-15 & 2015-16 is not eligible to participate in the competitive rates. The competitive rates in sealed cover are invited by 26th August, 2017. The bid for competitive rates will be opened on 26th August, 2017 at 11.00 AM in the office chamber of the undersigned.
